



Annual Meeting – Committee Reports January 27, 2019

Deacon's Report

Reflecting on the past year with all our wonderful worship services, special services, events and activities, regular monthly meetings, and planning meetings, 2018 appears to be consistent with previous years—that is on paper. Throw into that mix the changes and challenges of the past year, and I think we can all agree that it was an atypical year. We began our year with high hopes and dreams for new and exciting things to come at St. Francis'. Instead, as a community, we faced an extensive series of unimagined life-threatening and life-changing events. However, we do find ourselves on the other side of 2018 as we look with new eyes to 2019. I believe God has been with us on this year's journey, supporting us, comforting us, and shepherding us. There are many things that we can take satisfaction in, during 2018. Here is a sampling of some of those activities where we served Christ by serving others.

During the season of Lent, we took on a Campaign of Kindness. Through this outreach campaign, St. Francis' provided exceptional support to the Circle of Concern with baby-care items, the Open-Door Animal Shelter with dog and cat supplies, and the Episcopal City Mission with white t-shirts and socks. And later in the year, St. Francis' again, supported the Episcopal City Mission in their Christmas Gift Program by providing specific Christmas gifts for children in detention. I am in awe of your generosity and enthusiasm in supporting those in our area who are less fortunate than ourselves. I am so very blessed to be a part of this community.

During the fall season, Father AI and I together offered training and review sessions for Lectors, Eucharistic Ministers, and Acolytes. In the early months of 2018, we were learning how to live into our new worship and adjusting and reconfiguring our movements. There were a lot of kinks to sort through and we have made great strides in making our movements during worship more synchronized. Furthermore, these sessions brought new participants into these important worship ministries.

In 2018, I continued to be active in our Diocese. In December, I concluded my three-year term serving on the Diocesan Council. In 2019, I am looking forward to my new appointment to serve on the Commission on Ministry. Additionally, I attended the quarterly gatherings of the community of Deacons that were held at Eden Seminary in Webster Groves, and last spring I attended our Clergy Retreat.

Lastly, I believe God is asking us to reconsider the hopes and dreams we had for 2018 and refresh them into innovative and broader aspirations. We can achieve this by remembering our Baptismal vows. Whatever we, St. Francis' Church, may hope and dream for as a community, our Baptismal vows serve as the foundation on which we build and develop our goals in the coming year. By asking ourselves the following questions, and with the help of the Holy Spirit, we can discern the direction and characteristics of our future ministries.

- What does continuing in the apostles' teaching and fellowship, in sharing communion, and being prayerful look like to you?
- In what ways can we stand up against evil?
- How will our ministries bring God's love to others?
- How will we seek, serve, and love Christ in all persons?
- What efforts do we need to make that are respectful, and brings justice and peace to all persons?

Eureka Food Pantry

As you enter our worship area you may notice a red wagon...this represents and functions as a meaningful symbol of an outreach program we have participated in for decades...the Eureka Food Pantry. Being aware that many neighbors in our community and those nearby have people who need help each month providing enough food for their household - pastors of local churches developed a service program to offer help. The Eureka United Methodist Church provided a

space in their lower level and staffed it with volunteers from our region, including a couple from St. Francis'.

The dedicated staff usually help one morning a month with sorting donated items, distributing balanced food items to clients, and enrolling new clients. This is a simple matter for anyone who feels in need - a brief form to fill out and then they are eligible to be served with bags of food and other items once a month.

ALL items donated to directly to the Pantry....there are no overhead costs. Boy Scouts, high school classes, community social organizations, and many generous individuals keep this important outreach project humming along.

In addition to non-perishable foods there is always need for paper products (tissues, TP), soaps and cleaning solutions, sanitary products. During the summer successful home gardeners will bring in extra produce that contribute fresh foods. Cash donations are also welcomed and used to purchase meat and milk.

You are welcome to add to the wagon anytime you arrive. We have been delighted to see how quickly it fills up from week to week. If you have any questions speak with Arlene.

Grounds Committee

At the 2018 Bishop's Committee Retreat, a decision was made to form a Grounds Committee whose responsibilities would include drawing up a master plan for utilizing the property of St. Francis and plans for a children's sensory garden if St. Francis were awarded the national UTO grant.

Master Plan for the Grounds

Members of St. Francis met at 9:30 a.m. on Sunday mornings for several months to discuss the building and grounds. This collaboration resulted in a master plan that included a memorial garden, a sensory garden, a community garden, a garden/storage shed and a fellowship/meditation area. The plan was drawn up and presented to the BC at the May 20th meeting where it was approved.

Gardens and Grounds

The garden work in 2018 consisted primarily of weeding, watering, and pruning. Many thanks to the nine parish members who helped with the considerable watering the new plants required. Thankfully, most of the plants survived the winter. Five boxwoods had to be removed for which Hillermann Nursery gave us a credit of \$122.50 to use for replacement plants. Members contributed hoses, hose reels, a rain gauge and watering equipment to facilitate the watering effort.

In May, the pile of dirt remaining from construction located between the parking lot and Howerton was leveled out in the area next to the graveled auxiliary parking area. A couple of water problems surfaced during the spring which were attributed to drainage problems. The water in the utility room was attributed to a combination of a poorly-installed downspout and an area next to the building which needed to have the soil and mulch replaced with gravel and rock. The downspout was redirected, and the soil and mulch replaced. No water problems have resurfaced in the utility room since that work was done. Water on the community room floor was also attributed to poor drainage. Some work was done to remediate that problem and more work will need to be done in 2019 to avoid future problems. During October, several work days were held to remove and burn brush in the area where the Memorial Garden was to be located.

Building of the Memorial Wall and Garden

Starting with the conceptual plan for the wall provided by the Memorial Garden Committee, engineering plans were drawn up for the wall and sidewalk. Bids were acquired and a proposal was written up and given to the Bishop's Committee for approval. At the September 16th meeting, the BC approved the updated site plan, the acceptance of the construction bids, the acquisition of a building permit and the awarding of the contracts. Amid much delay because of the weather, the construction of the wall was completed on December 19th.

Expenses for building the Memorial Wall were:

Still outstanding is \$200 to Gullet Construction when the temporary pipe is removed. A final inspection with the City of Eureka Building Department still needs to be scheduled.

Grounds Committee Plans for 2019

- Complete the Memorial Garden area with a border, mulch and plantings
- Build the arbor on the Memorial Garden walkway
- Replace plants in front gardens
- Build a sidewalk from the driveway to the Memorial Garden walkway as shown on the master plan.
- This will include rocking the ditch that exits the bioretention basin and placing a culvert in the ditch.
- Cut off the yard drain in the front garden and connect the downspout to it. This will look better and
- should eliminate the washing of mulch onto the front walk.
- Replace soil under edge of the building stone facing with gravel which should alleviate drainage
- problems next to the community room and prevent problems with rodents tunneling.
- Plan the planting of the bioretention basin

Annual Address 2019

Recently I did a Google search for the word, "change", 12,430,000,000 results came up. Kind of mind boggling isn't it. Change is an inevitable part of human life. From science and technology to community, our homes and our bodies change is constant. The new cell phone you purchased yesterday morning is already out of date. Perhaps that is why so many people seek something that they do not believe will change. Many seek the unchangeable in the Church, but change is also an inevitable part of the life of the Church. How can the Church willingly change when the Church is one place that the majority of people look to for consistency? The misunderstanding is that many confuse the unchangeable truths of God with that vehicle chosen by God to reveal those truths. That vehicle is the Church. When the Church does not change in its approach and ways of accomplishing its work it languishes. When it does not change to meet the challenges of new eras and situations it stagnates. St. Paul reminded us that the Kingdom of God on earth continues to groan in its birthing pains toward its completion at the Second Coming of Jesus Christ. He wrote in the Letter to the Romans, "We know that the whole creation has been groaning in labor pains until now; and not only the creation, but we ourselves, who have the first fruits of the Spirit, groan inwardly while we wait for adoption, the redemption of our bodies."

The Church serves the Kingdom of God between the birth of the Church on Pentecost and the Second Coming of Christ. When Christ comes again, the Church having served its purpose, will cease to exist. For the Church to serve the Kingdom of God the Church must change, as must the people in it – not for the sake of change, but rather, so that the Church can effectively reach out beyond itself. Archbishop Temple was the Archbishop of Canterbury from 1942-1944, and he wrote this insightful truth, "The Church is the only society that exists for the benefit of those who are not its members." The Church must be effective in a world that changes. The Church must be willing to meet the challenges of new times or else its voice will not be heard by those who need to hear it the most, those outside of the Church. Change is inevitable for the Church. Remember, the Church does not belong to us, but rather, we belong to the Church. In his book, The Purpose Drive Church, Rick Warren makes this clear when he writes, "Jesus founded the church, died for the church, sent his Spirit to the church and will someday return for his church. As the owner of the church, he has already established the purposes, and they are not negotiable. Our duty is to understand the purposes Christ has for the church and to implement them. While the programs must change in every generation, the purposes never change."

On the other hand, change is not easy. Even when a congregation calls a new pastor to lead them to new places change does not happen all at once and not without conflict. Once a pastor begins his/her new ministry in a place it can take a long time for the work that the Holy Spirit is doing to effect the change that is necessary for that community of faith – change does not happen all at once, for the fruit of the movement of the Spirit is gradual.

The Gospel reading today introduces the very beginning of Jesus 'public ministry. He was birthed into change through his baptism by John and through his desert experience. In today's reading Jesus had just returned from his sojourn of 40 days and nights in the desert where he had been tempted by Satan to follow a path other than the one willed for him by his Father. Although Jesus refuted Satan in the desert, the evil one left him only for a while. During Jesus' ministry the evil one would appear again and again in many different forms, always with one

intention in mind, to dissuade Jesus from the purpose that God had ordained for him, in other words, disobedience to his Father's will. What happened to our Lord and Savior also happens to you and me, and as Jesus' disciples, we should expect nothing less. Throughout my life the evil one has appeared in many guises, but with one purpose in mind, to dissuade me from obedience to the will of God. Have you had similar experiences? Has Satan attempted to thwart God's purpose for you and your ministry? You know, the evil one especially delights in misdirecting the Church. There is great celebration in the hell when women and men of the Church falter, when we turn against each other, when we refuse to move forward, when we ignore the will of God. Whatever God's plans for St. Francis' Church may be, Satan has but one, to thwart anything that God wants us to do. As God's ministers, you and I must remain alert and vigilant, for the devil, as St. Peter tells us, goes about like a raging lion looking for someone to devour.

God has a purpose for each of us, a Divine plan that unfolds throughout our lifetimes. Part of God's plan for you is that you worship and work for the sake of the Kingdom of Jesus Christ through this particular community of faith. It is God's purpose that you are part of St. Francis' Church. As the Prophet Isaiah wrote, "I am the LORD, I have called you in righteousness, I have taken you by the hand and kept you." iv Our personal spiritual needs, comforts and growth are important parts of our faith journey, for to live in God's abundant grace is wonderful. It is wholesome and refreshing to be fed at the Table of the Lord, both through Holy Scripture and by the Body and Blood of the Lord Jesus, to be part of a loving and caring community, and to know with assurance that God loves you and eagerly seeks you. But God does not intend for you and me to be content only to worship here, only to live our community life together in fellowship, for God's plan extends beyond our personal spiritual needs and comfort of fellowship. In one of our Eucharistic Prayers we pray, "Deliver us from the presumption of coming to this Table for solace only, and not for strength; for pardon only and not for renewal. Let the grace of this Holy Communion make us one body, one spirit in Christ, that we may worthily serve the world in his name." To this prayer the people gathered respond: "Risen Lord, be known to us in the breaking of the Bread." We eat and drink the Body and Blood of Christ for reasons greater than our own, for such becomes our strength to do the work of the Church in service to the world. In word and sacrament, we are renewed personally and reconfirmed in our Baptismal Covenant to make Christ known to the world.

St. Francis' Church is called to be a purpose driven church, but the purpose that drives us, that propels us forward must be God's plan for us, God's purpose for us. St. Francis' Church does not belong to you and me. We are not the owners and therefore not the ones who have the right to determine the purpose, the direction for this church. Jesus established the church, died for it, empowered it through the Holy Spirit, and gave it a mission and ministry to make his name and salvation known throughout the world. You and I are the stewards of the church and its mission and Jesus will come back to claim it, and you and I will have to give an accounting of our stewardship. In The Purpose Driven Church are listed five signs of spiritual and bodily health that our church must experience for it to remain viable and to grow: "Churches grow warmer through fellowship. Churches grow deeper through discipleship. Churches grow stronger through worship. Churches grow broader through ministry. Churches grow larger through evangelism." These five signs constitute a measuring rod for you and me, for they are a standard by which we should measure our faithfulness to the purpose God has for this church. These are not five neatly divided areas because they all overlap and should, but all of them must be in balance with the

other, just as all must be biblically based, nor are these five basic principles an end in themselves, but rather, must be developed along with their concomitant attributes. These five signs are found in Acts 2: 42-47. These are the founding principles of the Apostolic Church, and these should also be our principles. These principles are also found in our Baptismal Covenant and promises. We repeat these principles each time there is a baptism and renew them at other times during the Church year. In her wisdom, the Church knows our weakness and so reminds us continually of who we are and what we are called to do.

In the hymn, "Be Thou My Vision" the writer proclaims that God alone, the Lord of our hearts is our center and is the wisdom by and through which we are to live out our lives. The vision of and purpose for St. Francis' Church must be guided by the vision that God has for us. From the God inspired vision that a small number of women and men were given St. Francis' Church was birthed in the early 1990's. Throughout the struggles during those early years God's purpose continued to inspire pastor, lay leaders and members. Ministry outside of the church was hampered by the lack of a building, yet this congregation managed to reach out beyond itself into the community to do the work of the Gospel. When we look back on the history of St. Francis' Church, it is obvious that time and again this community of believers faithfully discerned God's plan and followed through the purpose that God had in mind. As with any community of believers, our desire is always to be faithful, but sometimes we have not been able to move forward because we needed to rest, or because of internal conflict we needed to heal, or sometimes because we did not have the consistent leadership of a pastor. During the seven and a half years of Pastor Sally Weaver leadership St. Francis's Church continued moving forward. We grew warmer through our fellowship, deeper through discipleship, stronger and broader through worship and ministry. Flyer Blitzes were in response to evangelism.

From this community of faith's modest beginning at a meeting on January 7, 1990 at Eureka United Methodist Church to today you, the members of St. Francis Church have sought to do God's will and live God's purpose. The product of your faithfulness is this building. Space to meet, to learn, to worship, for fellowship, to invite others in now belongs to you. In addition, you have a day care center that serves young children and their families. Well done, good and faithful servants!

After Pastor Sally left in early June you needed to grieve, to regroup and to rest. When I arrived as your Interim Pastor in early September, I discerned that resting needed to continue for a while. The time for rest was evidenced by the hard work in which so many of you have been engaged and a need to grieve the departure of Pastor Sally. However, this is not the time to say, "I have done my part and my work is finished." Rather, it is the time to roll up our sleeves once again, invite fellow parishioners to join in and all of us together set about to do the work that God has for us.

We participate and enjoy our many opportunities for fellowship. There are additional opportunities for fellowship now that we have our beautiful building. For example, on Shrove Tuesday, March 5, the day before Ash Wednesday, we are planning a pancake supper. This is a wonderful opportunity for the men of our church to gather together and feed not only our community, but also, to invite others to join us. What other fellowship events are out there – opportunities to also involve the larger community? Fellowship does not stop with social events,

for instance the crafternooners gather for lunch, socialize and knit hats and scarves to be distributed to those less fortunate, and so it combines fellowship with ministry. Fellowship does not stop with welcoming visitors or new people on Sunday mornings. Fellowship means a community built on friendship, love, and common goals. The fellowship of the Church goes beyond Sunday mornings. Fellowship means taking a genuine interest in others, both current and new people. Fellowship means to give up some of my time and interests to be present and interested in other people. Fellowship means developing a warm and caring attitude for each other – to be genuinely interested in the welfare of others. Fellowship means to keep each other in our prayers and thoughts. Some of us do that publicly on Monday evenings during Evening Prayer with intercessions for the parish family. Fellowship means to have the best interests of each other in mind and heart. Many participate in fellowship. Can more of us participate? Can we pool our ideas and come up with other fellowship events?

Fellowship leads directly to discipleship. A disciple is one who walks in the footsteps of the master. How do we walk in Christ's footsteps? A proven way is through study of the Holy Scripture, Adult Forum and participation in small group discussion. Fellowship binds us together and discipleship deepens our fellowship and makes us more aware of the teachings of Christ. Some of us engage in book study and some in Bible Study. Can we add additional programs? Can we participate in additional Bible Study programs at other times? St. Francis Youth Program is in respite. The Diocese offers occasional venues for youth to gather together. Perhaps we can join other Christian communities from time to time. Churches should not wait until young people show up to start a program; a program needs to be in place. How do we revive and attract youth to our program?

Sunday morning worship should be inviting to visitors, even though we gather for worship on Sundays because of us. Our liturgy, prayers, sermon, songs, and Holy Communion focus on worship, discipleship and fellowship that strengthen our common bond. Forgiveness and blessing abound in worship. All we have to do is avail ourselves of that grace. Your yearning for a deeper spirituality through the preaching and teaching word and through the Sacraments of the Church is experienced in worship, discipleship and fellowship. My hope is that we will continue to grow in all these areas.

Ministry grows naturally out of discipleship and worship and strengthens fellowship. Ministry is greater than serving in worship on Sundays and weekdays. Ministry involves outreach, teaching, and giving of self to others. The new Memorial Garden is a ministry that reaches not only the St. Francis community but beyond. Our Tutoring program is a magnificent example of ministry, as is Trinity Hot Lunch, knitting by the crafternooners, Adopt-a-Family, Episcopal City Mission Christmas giving, Eureka Food Pantry, the Shoe Drive and participating in local events. Ministry touches on evangelism but mainly reaches out to others so that you can share with them the love of Christ and healing and comfort that God's grace brings to us.

Evangelism is where the Great Commission given to all who are baptized into Christ, fellowship, discipleship and ministry come together. "Before I formed you in the womb, I knew you, and before you were born, I consecrated you; I appointed you a prophet to the nations" vi These words spoken to Jeremiah over 2,600 years ago are just as viable and true today as they were then. God consecrated you and me before we were born to be God's prophets, to carry God's word to others. That is what a prophet does – carry God's word, that is, share God's word with another.

It is my hope that we will do better work in inviting others to this community of faith. This is part of the Baptismal Covenant and a very serious job that you have. You are to use the gifts you have been given by the Holy Spirit to bring others to Christ. Flyer Blitzes continue to be a worthwhile endeavor. Are you willing to participate in this evangelism tool? To bring others to Christ is not a choice, but rather, an obligation laid on each of us by Jesus himself. We all work toward this goal. What about planning Friend Day events - inviting someone to worship and fellowship. Are there events we can plan for 2019 and beyond? We do not have an Evangelism Committee. An Evangelism Committee would enhance our efforts at inviting others to our church and planning events. A new committee for evangelism does not usurp your responsibility to bring new people to St. Francis' Church. Coupled with our evangelism effort is attracting younger families and youth to our church. One of the things an Evangelism Committee could consider would be adding a contemporary Eucharistic service on Sunday evenings? All of us can start now by making a concerted effort to welcome visitors. Let's show others that we are a warm, loving, and inclusive parish. Bringing others to Christ is a primary goal for anyone who attends St. Francis' Church. If you do not have any friends who are unchurched - make some new friends and then bring them to Christ. If each family unit brought one new member to St. Francis' Church each year just think of what our growth would be. There are so many people around us who do not know Christ.

Each and every one of us must work toward our spiritual and faith development. This means regular attendance at worship on Sundays. Occasional worship does not help us to grow spiritually! Participation in Adult Forum is a good way to begin this journey as well as participation in other spiritually oriented events.

If we are willing to grow warmer through fellowship, spiritually deeper through discipleship, stronger through worship, broader through ministry, and larger through evangelism God's blessing will abound and grace will be showered upon us. You have God's word on it.

BYLAWS

ARTICLE I. PROVISIONS

- 1.) The Mission of St. Francis' Episcopal Church (St. Francis' or Mission), as part of the One, Holy, Catholic and Apostolic one holy catholic and apostolic Church of Christ, acknowledges its allegiance to the Protestant Episcopal Church in the United States of America (Church) and to the Episcopal Church in the Diocese of Missouri (Diocese).
- 2.) The Mission submits to the authority of the General Convention of the Church and the Convention of the Diocese.
- 3.) The Mission accedes to, recognizes, and accepts the Doctrine, Discipline, and Form of Worship of the Church and the Constitution and Canons of the Church and the Diocese, as may hereafter be amended from time to time.
- 4.) In the event of any conflict or inconsistency between the organizational documents of this Mission and the Constitution and Canons of the Church or the Diocese, as may hereafter be amended from time to time, the Constitution and Canons shall control and govern.
- 5.) The foregoing provisions may not be altered or deleted without the written consent of the ecclesiastical authority of the Diocese.

ARTICLE II. PURPOSE

The purpose of these bylaws is to provide rules and regulations for the administration of the affairs of St. Francis' Episcopal Church.

ARTICLE III. MEMBERSHIP

A person who by Baptism, Confirmation, Reception, or Letter of Transfer is duly recorded in the register of this Mission and in all other aspects is in compliance with Title I, Canon 17.1 Section 1 a & b of the Constitutions & Canons of the Episcopal Church is considered a member of this Mission. In addition, any person who attends worship regularly at St. Francis', participates in the life of this community of faith, and supports this mission with their financial resources is considered a member of this Mission.

ARTICLE IV. GOVERNMENT

Section A. The Mission shall be governed by a Bishop's Committee (Committee) consisting of ten (10) members, one of whom shall be the Bishop's Warden (Senior Warden); one of whom shall be the Junior Warden; the Secretary, who is appointed by the Vicar from the Committee or the congregation; the Treasurer who may be selected from the Committee or the congregation. If not members of the Bishop's Committee the Secretary and Treasurer will have voice but no vote. Members of the Committee shall be lay adult communicants of St. Francis' Mission who have reached 16 years of age and shall have regularly attended and been supporters of the Mission during the past six months. The Bishop, after consultation with the Vicar, shall appoint the Mission's Bishop's Warden and Treasurer. Members of the Bishop's Committee shall be elected to a three-year term and after serving a full term will be eligible for reelection after the expiration of one year.

<u>Section B.</u> The Bishop's Committee shall lead the Mission in the proclamation of the Gospel, provide for the public worship, nurture persons of all ages, alleviate human suffering and promote justice.

Section C. Meetings of the Bishop's Committee shall consist of:

- 1) The Vicar, who shall be without vote, except to break a tie, shall preside at all meetings with the Bishop's Committee.
 - 2) The Deacon, who shall have voice but no vote.
- 3) The Bishop's Warden, who shall preside in the absence of the Vicar or at the Vicar's discretion.
 - 4) The Junior Warden
 - 5) The Treasurer
 - 6) The Secretary
- 7) The Diocesan Convention Delegate(s) and Alternate (Convention Delegate(s) and Alternate), not otherwise a member of the Bishop's Committee, shall have seat and voice but no vote and shall not be counted toward a quorum.
- 8) Nine (9) lay members to be The lay members having been elected in accordance with Diocesan Canon IV.3 Sections 3, 4, 5 & 6

Section D. Meetings of the Bishop's Committee shall be held on the third Sunday of each month or on such a date as may be set by the Bishop's Warden or Vicar. Special meetings may be held by call of the Bishop or the Vicar, on at least five (5) days' advanced notice.

A special meeting of a Mission may be called:

- (1) by the Vicar;
- (2) if there be no Vicar, by the Bishop's Warden;
- (3) by the Bishop; or
- (4) upon written request by a majority of the Bishop's Committee or by one third of the electors of the Mission, delivered to the Vicar, or if there be no Vicar, to the Bishop's Warden.

Notice of every special meeting shall be given in advance at two public services at least fourteen days apart.

Section E. Meetings of the Bishop's Committee are open to the Bishop, the Bishop's representative, the Vicar, the Deacon, Wardens, Secretary, Treasurer, Members of the Bishop's Committee, and all others interested in attending. Voice (but not vote) may be given to anyone, with advance notice to the Vicar or Bishop's Warden. Rarely, the Bishop's Committee may meet in Executive session to consider highly sensitive matters, e.g., personnel issues. When the Bishop's Committee is in Executive session, only members will be present.

Section F. A majority of the Bishop's Committee shall constitute a quorum and a majority of such quorum shall be required for the transaction of any business except as otherwise required by the Canons of the Diocese of Missouri.

Section G. Any member of the Bishop's Committee who, without reasonable justification, shall have missed three (3) consecutive meetings or who shall otherwise fail regularly to attend meetings of the Bishop's Committee may be removed from his or her office by the Vicar, at which time the remaining members of the Bishop's Committee shall select an eligible candidate from the congregation to fill his or her expired term as set forth in Diocesan Canon IV.3 Section 6.

ARTICLE V. ANNUAL MEETING

Section A. Members of this Mission shall assemble in Annual Meeting to elect successors to those members of the Bishop's Committee whose terms have expired, delegate(s) and alternate(s) to the convention whose term has expired, to approve an annual budget, and to transact such other business as shall be brought before them. The Meeting shall be the first Monday in January, or as soon thereafter as practical and notice of time and place shall be given at all public services on the two Sundays immediately preceding the meeting. At the Meeting the Vicar shall preside.

<u>Section B.</u> A quorum for Annual Meeting shall consist of twenty-five percent of the total number of qualified electors. Electors at the Annual Meeting shall be communicants at least sixteen years of age and shall have been members of St. Francis' for at least six months prior to the election.

Section C. Nominations for lay members of the Bishop's Committee may shall be made by a Nominating Committee, appointed by the Bishop's Committee, and by members of the congregation through the Nominating Committee. Voting shall be by ballot and no proxies shall be permitted; provided, however that, by unanimous consent, the rules may be suspended, and the Secretary of the Meeting be directed to cast all votes present for any candidate(s).

Section D. Lay Delegates to Convention shall be chosen by the Congregation in the same manner as provided for the election of the Bishop's Committee. Any vacancies that occur may be filled by the Bishop's Committee. Lay Delegates shall be chosen for staggered

terms of three years, and each year there shall be elected the number required to replace those whose terms expire. No Lay Delegate having served a full term of three years shall be eligible for reelection as Delegate or Alternate until after one year.

ARTICLE VI. DUTIES OF THE BISHOP'S COMMITTEE

Section A. The officers of the Bishop's Committee shall consist of the Bishop's Warden, the Junior Warden, the Treasurer, and the Clerk or Secretary of the Committee, all of whom shall subject to their role as agents of the Corporation of the Episcopal Diocese of Missouri, be accountable to the Vicar and except as set forth below to the Bishop's Committee.

Section B. The Executive Committee shall consist of the vicar, the Wardens, and the Treasurer. The Executive Committee shall confer prior to each monthly meeting of the Bishop's Committee to prepare the agenda for that meeting.

Section C. The Bishop's Warden shall act as presiding officer in the absence of the Vicar. He or she shall act as the confidant of the Vicar and shall generally represent the interests of the congregation to the Vicar and the Bishop in accordance with Section A., above. In the absence or illness of the Vicar, or during a vacancy in the Vicarship (except to the extent such power has been delegated to an Interim Pastor or Priest-in-Charge by written employment agreement) the Bishop's Warden shall preside at meetings of the Bishop's Committee and of the Mission. The Bishop's Warden shall be appointed annually by the Bishop. He or she shall be eligible for election to a full term as lay member of the Bishop's Committee following any term as Bishop's Warden but shall not serve as Bishop's Warden for more than three consecutive years. In the event any person is appointed Bishop's Warden who is then a lay member of the Bishop's Committee, such Bishop's Warden shall thereafter continue as if he or she had not held office as a lay member and may serve for three years.

The Bishop's Warden shall be appointed annually by the Bishop in consultation with the Vicar. He or she shall not serve as Bishop's Warden for more than three consecutive years. In the event any person whose term as Bishop's Warden ends prior to the end of their three-year term on the Bishop's Committee, such person shall thereafter continue as if he or she had not held office as Bishop's Warden and may serve as a lay member for the remaining portion of their three year term.

Section D. The Junior Warden shall be elected annually by the Bishop's Committee from its membership according to the Constitution and Canons of the Diocese of Missouri. The Junior Warden shall fulfill the duties of the Bishop's Warden if that person is unable to serve. The primary focus of the Junior Warden shall be the upkeep and maintenance of the building and grounds of the parish.

The Junior Warden shall not serve for more than three consecutive years. In the event any person whose term as, Junior Warden ends prior to the end of their three-year term on the Bishop's Committee, such person shall thereafter continue as if he or she had not held office as

Junior Warden and may serve as a lay member for the remaining portion of their three-year term.

Section E. The Mission's Treasurer shall be appointed annually by the Bishop, after consultation with the Vicar. He or she shall keep accurate accounts of monies received and disbursed by or for the benefit of St. Francis'. He or she shall present a detailed report each month at the Bishop's Committee and a similar report to the congregation at its Annual Meeting. He or she shall deposit monies received in such places of safe keeping as may be designated by the Bishop's Committee, such monies to be in the name of St. Francis' and to be deposited on the first available banking day after its receipt. Such funds shall be disbursed as ordered by the Bishop's Committee; provided however, that routine bills shall be paid by the Treasurer and reported monthly with his or her regular report (see Canon IV.3 Section 9, Appendix B).

Section F. A Clerk or Secretary shall be appointed by the Vicar and affirmed by the Bishop's committee at its first meeting after the Annual Meeting. The Secretary need not be a member of the Bishop's Committee. The Clerk or Secretary shall keep records of the proceedings of the Annual Meeting, of meetings of the Bishop's Committee, and shall perform such other reasonable duties as may be designated by the Vicar. Copies of approved minutes of all meetings shall be posted on the church bulletin board within two weeks following such meetings and shall remain posted for not less than two regular services not less than fourteen days apart. Copies shall also be sent to the Canon to the Ordinary and the Bishop and to all members of the Bishop's Committee.

Section G. It shall be the practice of the Mission to appoint Tellers, who must be members of the Mission as defined in Article III, to record monies donated to the Mission each Sunday. Tellers shall act in pairs to count and record monies donated to the Mission, and to ensure that the monies are deposited as soon as possible in such places of safe keeping as may be designated by the Bishop's Committee.

Section H. Routine expenses designated by the Mission's Annual Budget may be paid at the instruction of the Vicar or the Treasurer. Non-budgeted expenses under \$500 may be paid at the authorization of the Vicar, provided that the expenses are reported at the next Bishop's Committee Meeting. Non-budgeted expenses over \$500 should be approved by the Bishop's Committee; however, the Executive Committee may by a majority decision approve urgent expenditures of funds. In the latter case, the expenditures must be reported at the next Bishop's Committee meeting with an appropriate explanation of the urgency of the expenditure.

<u>Section I.</u> The Bishop's Committee shall have the authority and power to appoint such other officers and subcommittees and perform such other duties as are not prohibited by the Constitution and Canons of the Diocese of Missouri.

<u>Section J.</u> The Bishop's Committee shall adopt and approve a proposed

budget prior to the annual meeting. The proposed budget shall be made available to all at the scheduled Annual Meeting.

ARTICLE VII. PROPERTIES AND INDEBTEDNESS

See Canon IV.3 Section 8

ARTICLE VIII. BUSINESS METHODS

The accounts of the Treasurer, Wardens, Trustees and Custodian of Funds of the Mission shall be audited annually. The audit shall be made by a certified public accountant, or, if this is not practicable, by some other person or persons approved by the Treasurer of the Diocese. The auditor shall be appointed by the Bishop's Committee at least thirty days before the end of the year and shall not be a member of the Bishop's Committee or governing body of the organization whose books are to be audited. A certificate of audit shall be sent to the Bishop by July 1 of each year covering the financial reports of the previous fiscal year.

ARTICLE IX. AMENDMENTS AND CONFLICTS.

Amendments

These bylaws may be altered, amended or repealed and new bylaws may be adopted provided they are in harmony with the Canons of the Episcopal Church and the Diocese of Missouri and approved by an Annual or Special Meeting of the Mission.

Review

These bylaws are reviewed for accuracy by the Bishop's Committee annually. The bylaws indicate that reviews/revisions have been conducted.

Conflicts

In the event of any conflict between these bylaws and the Constitution or Canons of the Diocese of Missouri or the Church, as now in effect or hereafter amended, the provisions of these bylaws shall be deemed to be amended to conform to the requirements of said Constitutions and Canons.
